#### The City Multan

Multan, the city of saints, has been a center of learning, culture and civilization for centuries. It is one of the oldest living cities of the world. Its original name as described by Hiuen Tsang, a Chinese traveller, who visited the city in October 641 A.D., was 'Mu-losan-pu-lu', which is believed to be a translation of 'Mulasthana-Pura'. Al-Beruni, who came to South Asia in 1015 A.D. alongwith his Master Sultan Mahmud Ghaznavi, writes about the town as 'Mulatana'. He visited Multan the same year and recorded that Multan was originally called 'Kasyapapura, then Hansapura, then Bhagapura, then Sambapura and then Mulasthana. Sir Gen. Alexander Cunningham, after conducting excavations in the old fort in 1853 A.D. and 1864 A.D., further adds to these names those of 'Prahladapura and Adysthana'. The first recorded event in the history is the invasion of Alexander the Great in February 325 B.C.

Several other important historians visited Multan including Masudi (915 A.D.), Istakhri (951 A.D.) and Ibn Batuta (1334 A.D.) and they all wrote about the social, cultural and educational activities in Multan. Multan's importance has always been acknowledged and it has always maintained its distinguished and honorable position among the cities of this region.

The city (740 ft. above sea level) is located almost in the center of Pakistan. It is at a distance of approximately 950 km from Karachi and 630 km from Islamabad, right on the main highway and about six kilometers from the mighty Chenab, in a bend created by the five confluent rivers. The vast plain of Multan Division is dissected by rivers, canals and narrow water channels, forming an ideal agricultural base for the economic development of the region.

# The University

Multan has always remained a centre of excellence in education. Hazrat Bahauddin Zakariya (1172 - 1262 A.D.) a Muslim religious scholar and saint, established a school of higher learning in theology in Multan; where scholars from all over the world came for studies and research. Multan has maintained its central position and centuries old cultural heritage and therefore suited ideally to become a center for learning. Thus the University of Multan was established in 1975 by an Act of the Punjab Legislative Assembly. To pay homage to the Great Saint, the name was changed from University of Multan to Bahauddin Zakariya University in 1979.

The University is located at a distance of 10 km from the city center. The main Campus is spread over 960 acres of land. The University has a fleet of 22 buses and 2 coaches which provides transport facilities to students and staff. The University started functioning in 1975 in rented buildings with 8 departments. Presently, it has more than 30 departments/institutes/colleges. Out of its 392 faculty members, 130 hold doctoral degrees and among its around 10,000 students, half are female.

The University offers a wide range of programs: M.A., M.Sc., MBA, M.Com., MCS, M.Phil, and Ph.D. Additionally, in recent years, the University has taken a lead in introducing 4-Year Undergraduate programs in Science, Commerce, Business, Pharmacy, Engineering, and English Literature and Linguistics. Various short-time courses and diplomas offered from time to time have become popular amongst the general public.

The University is widely known as a renowned institution for excellent performance and great ambitions and credentials it has continued to make speedy progress toward its goals. It plays a significant role in developing indigenous human resources through its highly productive achievements, both in Sciences and Humanities.

The University has made tremendous progress through different phases, but some recent developments are remarkable. To promote the activities of art and culture, Multan College of Arts was established in 2003. In order to cater to the needs of textile industry, being a major one of the area, the University College of Textile Engineering was established in 2004. The University has also established two sub-campuses at Sahiwal and D.G. Khan to provide education facilities at the doorsteps of the people as part of the policy of the Government. Steps have been taken to establish the University's linkages with the community and Industry. There has been significant enhancement in students' enrollment. To ensure quality in academics and research, Quality Enhancement Cell has been established. A large number of buildings are under construction. These buildings will provide better facilities to the students. The University has implemented semester system in almost all the departments and organizing international conferences and seminars has been a routine academic activity. A significant number of faculty members have been awarded post-doc research fellowships. The establishment of the Department of Siraiki, Institute of Biotechnology and Faculty of Veterinary Sciences are some recent developments.

#### **Directorate of Distance Education**

In Addition to the above developments, Bahauddin Zakariya University is continuously striving to extend its efforts for the development of education in its jurisdictions. The Vice Chancellor of Bahauddin Zakariya University is concerned to improve the quality of education of the external/private candidates appearing in different post graduate examinations. For this the Bahauddin Zakariya University is providing **Distance Education facilities** to the post graduate external/private candidates in its jurisdiction since August, 2009 and initially the facilities of **Distance Education** are limited to some Humanities and Social Sciences subjects. The library facilities will be at the Fearing centers.

The Bahauddin Zakariya University is the fastest growing public university in Pakistan, and it will continue to play a vital role in the development of the country.

# Administration (Bahauddin Zakariya University)

The University Senate is the supreme governing/legislative Body of the University. The Syndicate and Academic Council are the executive and academic bodies of the University. The Governor of the Punjab is the Chancellor of the University, whereas the Minister for Education, Government of the Punjab is the Pro-Chancellor. The Principal Executive and Academic Officer of the University is the Vice-Chancellor who is assisted by the Deans of the Faculties, Chairmen/Chairpersons of the Departments, Directors of the Directorates/Institutes/Centre, Principals of the Constituent Colleges, Project Directors of the sub campuses (Sahiwal & D. G. Khan) and the four Principal Officers of the University - the Registrar, the Treasurer, the Controller of Examinations and the Project Director (civil works).

#### Introduction and Rationale of Distance Education.

In Pakistan, a large number of students appear in various examinations, as external/private candidates. Such students have no access to formal teaching and learning opportunities due to many constraints. They largely depend on get through guides and other similar kind of low quality material available in the market. Consequently, their knowledge remains substandard and their skills are incompatible with the needs of the market. This is the reason that compelled the worthy Vice Chancellor (**Prof. Dr. Muhammad Zafarullaha**) of the university, to take the initiative to raise the standards of private students, training and education. Therefore Directorate of Distance Education launched MA programme in five disciplines in August 2009 and is successfully in progress..

Initially, the system was introduced in certain Humanities and Social Sciences disciplines at the Post-graduate level including **English**, **Economics**, **Pakistan Studies**, **Islamic Studies and Urdu** and will continue in future i.e. 2010 and onwards. On the success of existing programme the system will be extended to other disciplines and later to all over the country and to the Middle East countries.

The degrees, diplomas and certificates obtained through this system will be fully accredited and accepted everywhere as other degrees and certificates of Bahauddin Zakariya University. The facilities for providing teaching materials and guidance and other required and relevant services will be made available by Bahauddin Zakariya University through an effective and efficient rework of these services. An informal system including some structured, some semi-structured and some unstructured components will provide opportunities for learning with a flexible scheduling.

This year (2010) Distance Education students shall be admitted at the start of academic session i.e. August 2010 like regular students. No admission after the cut off date will be permitted. The project will be completed in 24 months time period. The students will be prepared year wise M.A. part I (1<sup>st</sup> year) and M.A. part II (2<sup>nd</sup> year). Each year, 9 months for preparation and the remaining time is in the establishment. Existing faculty as well as the examination department will coordinate with the directorate for the assessment of enrolled students.

# Objectives

- The major purpose of providing opportunities of distance education under the Bahauddin Zakariya University Multan is to enrich the experience of those students who appear in examination as external/private candidates, and, have no access to formal teaching-learning environment.
- The main thrust and the spirit of distance education system is maximum accessibility and flexibility as the students will have better opportunities for learning without affecting their everyday routine, work and job responsibilities and other commitments.
- The guidance may be provided to these students in the field of enhancement of knowledge, improvement of communication skills, preparation of examination etc.

#### **The Delivery Modes:**

The delivery modes for the distance education will be:

- 1. Course materials will be suggested by the Coordinators/ Tutors.
- 2. Instruction and support from the tutors appointed for the purpose through mail or online.
- 3. Tutorial meetings (Twice a month) to be held at appropriate places with predetermined and fixed frequencies and schedules (mandatory to attend).
- 4. Workshops (Twice a year) to be held at appropriate places with predetermined and fixed frequencies and schedules (mandatory to attend).
- **5.** All instructions and notices to the students will be given through internet on Website: www. bzu.edu.pk

#### **Evaluation:**

The admitted students will be examined with Regular and external/private students appearing under annual system of examination. The content of the syllabi will be same as for the regular and external/private students appearing under annual system of examination. The evaluation will be bifurcated into the following:

- Credit for participation in Assignments, Tutorials and Workshops (weightage i.
- Formal examination at the end of the year (weightage 80%). ii.

#### **Coordination with students:**

The Directorate of Distance Education has made the arrangements of coordinators and tutors for the students of each discipline. The coordinator of each subject will be the chairman/Chairperson/director of the respective department at main campus of Bahauddin Zakariya University Multan. The coordinator of each subject is responsible to make arrangements of tutors and other necessary requirements, regarding the proceedings of the programme. A brief introduction of each department at main campus along with a description of the courses to be offered to the students of each subject is produced below.

### **Department of Economics**

Department of Economics

The Department of Economics started functioning as soon as the University was established by transferring M.A. Economics classes from Government College, Bosan Road, Multan to the University. Teaching staff was also acquired on deputation from the same institution. At present, there are nine members of the teaching staff. Three of them hold Ph.D. degrees from abroad and one from Pakistan.

The Department offers a wide range of courses in the field of Economics. In line with the decision of Higher Education Commission (HEC), the Department of Economics has introduced BS (Hons.). 4 years program. The main purpose of this program is to provide the essential knowledge and skills of Economics to the students. The program offers promising choice to the students in the selection of their career at intermediate level.

Keeping in view the present day requirements of the subject, the Department of Economics is already offering exciting and academically challenging postgraduate degree of M.Sc. Economics boin as morning and a afternoon program (self-finance). The program provides a foundation in modern technique of Quantitative Economics, Financial Economics and Econometrics with emphasis on quantitative tools such as Mathematics, Statistics and Computer applications. The central feature of the course is its blend of core economic concepts and principles with modern research methods. Masters of Science in Economics is a two years postgraduate program.

The Department also aims at promoting research on various local and national issues. For this purpose the Department has introduced both M.Phil. and Ph.D. programs. Presently, twenty two students are registered as Ph.D. candidates. The students strength has now risen to over 250 per academic year.

The Department has a library of more than 5000 books, plus a collection of national and international journals. Computer facilities are also available in the Department. As a bilateral exchange program, the Department has established a linkage with the Molde University College, Molde, Norway. Accordingly, the Molde University College will offer one scholarship for Doctoral Degree Program each year. Presently, four faculty members of this department are studying in Norway under the said program.

### **Department of English**

The Department of English at the Bahauddin Zakariya University, Multan has a rich faculty and offers a wide range of programs and courses in English literature and linguistics. The Department has six PhDs and five M. Phils. in its regular faculty. It is one of the leading departments in the whole country in terms of teachings, faculty, number of programmes offered, diversity and richness of courses and modules, well equipped and updated library;

and, it at the fore front of research activity in areas such as ELT, sociolinguistics, discourse and gender studies.

The Department offers two Masters' degree programs: MA in English and M.Sc in Applied Linguistics. MA in English is predominantly a literature-based program; whereas, M.Sc in Applied Linguistics prepare students for effective teaching of English as a second/ foreign language. The M.Phil programme in Linguistics was started in 1999 which is meant for rigorous training in the field of Linguistics. The Department launched M.Phil in Literature in 2006 which is aimed at providing specialization in the field of Literature. The M.Phil programs in linguistics and literature ultimately lead to Ph.D. in Linguistics and Literature, also offered in the Department. The Department took an initiative by offering a four-year BA Honors degree in English Literature and Linguistics in 2003 which was the first ever of its kind in Pakistan. Now, the Department has taken another initiative by starting a distance education programme in MA English for the private candidates of the region, which is a traditional literature-based programme.

# **Department of Pakistan Studies**

The Department of Pakistan Studies came into existence as a result of bifurcation of the Department of History and Pakistan Studies on 04 June 1998. The Department of History and Pakistan Studies was established in 1976. Initially a diploma course in Pakistan Studies was introduced which was up-graded into a full-fledge M.A. Programme in 1987.

#### Department of Urdu

The Department was established concurrently with the University in 1975, when post-graduate classes of M.A Urdu in Government College, Multan were shifted to the University. The University Department thus not only inherited the class but also the bright tradition of the parent Department. The Department offers facilities for M.A., M.Phil and Ph.D. programs. Regular M.Phil Program started from the academic session 1992-93. Till last year, sixty three students obtained M.Phil degrees. Details regarding M.Phil and Ph.D. programs may be obtained from the office of the Department. In 2005, a Persian Certificate Course was started. In this program, 40 students got admission. All of them successfully completed the course.

Most of the graduates of this Department are serving as College and University teachers in Pakistan. Moreover, a significant number of graduates are media. Three of its prominent graduates, Dr Aslam Adeeb, Dr. Farooq Mashhadi and Dr. Saleem Haidrani have earned Quaid-e-Azam scholarship and obtained Ph.D. degrees from the U.K.
